# A day focused on giving back

G iving to people in need has always been part of the holiday season, but that spirit of goodwill took a supercharged spin in 2012 with the creation of Giving Tuesday, a day devoted to supporting and encouraging good works.

Eleven years later, Giving Tuesday has become a global effort that continues to reach new heights. According to an annual report by the GivingTuesday Data Commons:

- In 2022, people in the United States gave \$3.1 billion on Giving Tuesday, 15% more than in 2021 and 25% more than 2020.
- Last year, about 37 million adults donated to a charitable cause on Giving Tuesday, 6% more than in 2021

The original idea for Giving Tuesday came from the 92nd Street Y in New York City. The nonprofit encouraged people in its community to make the Tuesday after Thanksgiving a day focused on charitable giving. Soon, a broader movement was born. A separate nonprofit organization called Giving Tuesday was later created to organize and promote the global giving effort and to provide data, ideas and content to maximize the reach and impact.

From the start, social media has played a huge role. Charities and businesses use the hashtag #GivingTuesday to spread awareness and seek donations. People who are passionate about specific causes share posts and challenge friends and followers to join them in supporting their favorite charity.



The mission of A Step Beyond (ASB) is to prepare students for success in college, career and life through dance education, aca-

Our program is unique because ASB makes a 10-year commitment to students, from 3rd through 12th grades, at no cost to families. ASB celebrated its 10year anniversary this year, with our second student cohort entering colleges and trade schools after joining as 3rd graders in 2014.

### **Q:** How important are volunteers to your nonprofit?

Volunteers are extremely important to ASB, supporting our college and career readiness programming by speaking to students about their career journeys, providing mentorship and helping students to develop essential skills for the workplace. Volunteers also support academic tutoring, masterclasses in dance, food distributions for families and lend expertise on various ASB committees.

## **Q:** How does a monetary donation benefit your nonprofit?

Monetary donations are crucial to the continued success of ASB and the community we serve. Our highly efficient organizational model and the support of our donors allows us to underwrite the entire cost of the 10-year program free of charge. Students are all members of local families who live at or below the poverty levels and lack opportunities for enrichment, intensive academic support or mental health services.

## Q: Does your nonprofit have an annual gala or main fundraiser planned for 2024?

Our annual September wine tasting benefit features wines from around the world, rated no less than 90 points. Each spring, we host an ARISE performance and each fall, we produce "El Alebrije," a retelling of "The Nutcracker." ## Q: What impact does your nonprofit expect to make in the community in 2024?

Our 10-year anniversary signals a leap in our positive impact on the community by preparing greater numbers of students with tools to transcend poverty and succeed. Our expanded college readiness and scholarship resources are helping more students attend college and career programs aligned to their dreams. Our strengthened wellness services help keep students and their families stable through mental health and counseling services and emergency financial aid to avoid food and housing insecurity.

#### Q: Why dance education?

Dance education is a powerful way for youth to become engaged in their academic and career journey. Research indicates dance education enhances emotional well-being, reduces stress and mitigates symptoms of anxiety or depression. Strong kinetic dance arts programs activate multiple systems in students' brains, helping students make connections between new and past learning, holding their attention for longer periods of time and improving long-term recall.
